INTERMEDIATE SKILLS BOOT CAMP CONTRACT

1. This agreement shall be between Isa “GlitterGirl” Isaacs dba Temple of Poi., hereinafter referred to as “Temple of Poi” and, (insert student name here) _____, hereinafter referred to as “client”.
2. Client understands this intensive includes: 12 80 minute sessions: list price at \$30 per session is \$360; plus 1 30 minute private session: list price \$65. Total list price is \$425 list discounted to 3 payments of \$110 each (\$330 total).
3. Client will make \$110 payments in cash on or before the 10th of the 1st and 2nd months following the first day of the first class taken in the series. (I.E.: Student begins class on the 28th of May so payment 1 is due on or before that day and payments 2 and 3 are due on the 10th of June and July respectively.)
4. Client understands payments are non refundable and non transferable.
5. Client understands this tuition does not include additional gear, costumes, fuel, insurance and other expenses fire dancers may incur.
6. Client agrees to be on time for each session. Client understands that if a scheduled appointment begins late due to their failure to be available at the agreed upon start time, the appointment will still terminate at the appointed end time.
7. If Client is more than 15 minutes late for a session, Client understands the session will be forfeit and cancelled if the session is a private session.
8. Client further understand any missed appointment is forfeit.

9. Client agrees and understands that all schedule changes must be rescheduled via phone at Isa's Cell at 415.424.8581 or via email to glittergirl@templeofpoi.com.
10. Client understands class sessions may be made up at an additional fee of \$90/hour for a private session; or \$125/hour total for 2 - 4 people where appropriate and possible. Client understands that 1/2 private sessions may also be used as makeup sessions.
11. Client agrees to take on the Flowology Mindset™ as part of their poi practice for the duration of this boot camp program, understanding that their mindset is as important as their physical practice. A copy of the mindset is located at:

12. Client agrees to take an active role in the learning process by not only practicing, but being honest and forthcoming with Temple of Poi and themselves about any feelings or issues they have around the process, services, or Temple of Poi. Client is invited to check in with Temple of Poi in these matters in person, via phone or by email.
13. Client understands that Temple of Poi actively markets their business based on a formalized referral system. If client refers anyone who signs up for poi series classes at Temple of Poi and names them as the referring party, Client receives a \$15 discount for the new student. Client may accumulate referrals for multiple students and may apply said referrals to the cost of this program and/or any other Temple of Poi session with availability.
14. If any dispute shall arise concerning the interpretation or application of this Agreement, or the rights and liabilities of the parties arising hereunder, and such dispute cannot be resolved voluntarily between the parties themselves through reasonable, good faith efforts

to do so, resolution of such dispute(s) shall be sought through voluntary mediation in San Francisco, California, facilitated by a neutral third party mutually agreed upon prior to recourse by either party to any other remedy at law. Costs of such mediation shall be divided equally between the parties, unless the mediator, in his or her sole discretion, determines that, in the circumstances of the particular dispute, fairness requires a different division of costs. If mediation is not successful in resolving the dispute(s), the parties shall submit to binding arbitration under the rules of the American Arbitration Association, waiving all other procedural remedies at law other than for injunctive relief or for any claim subject to criminal complaint under the laws of the State of California or the United States.

- 15. Client understands this discounted program is offered because they agree to pay the fee of \$110 per month for 3 months regardless of which sessions they attend or do not attend.
- 16. For the duration of the boot camp period, Client may attend any additional Poilates™ I sessions with available spaces for \$15 and all flashcards sets may be purchased at a \$5 discount for Client.
- 17. This Agreement shall be construed and governed by the laws of the State of California.
